Beograd,</p> <p>2) General terms and conditions for opening, managing, and closing current dinar and foreign currency accounts for legal entities and providing payment services for these accounts,</p> <p>3) General terms and conditions for the provision of payment services accepting payment cards at points of sale, in accordance with the text reviewed at the meeting.</p> <p>2. The General Terms and Conditions from Item 1 are an integral part of this Decision.</p> <p>3. The General Terms and Conditions from Item 1 must be displayed in the Bank's business premises in a visible place and on the Bank's website, no later than 15 days before their implementation.</p> <p>4. This Decision shall enter into force on the day of its adoption.</p>
